Dear Representative Nunes and Representative Pallone:

The undersigned organizations are writing to express our support for the TELEhealth for MEDicare (TELE-MED) Act of 2013. We applaud your introduction of the bill and your continued commitment to advancing telehealth. We believe this is a solid step in expanding access to care while lowering costs for consumers through telehealth.

The convergence of medical advances, health information technology, and a nationwide broadband network are transforming the delivery of care to citizens by bringing the health care provider and patient together virtually, especially those in disadvantaged areas. More than 60 million Americans lack access to primary care services due to doctor and provider shortages at local practices, community health centers, and hospitals. In many rural communities, patients must travel long distances to health care providers to receive treatment. Telemedicine can mitigate these problems and holds tremendous promise to improve outcomes and to lower health care costs.

Congress has already expanded telehealth opportunities at the Department of Defense and the Veterans Administration for service members regardless of geographic location. The Veterans Administration has recognized that treating veterans at home is less expensive than treating them in a facility.

This proven model can and should be applied to the Medicare program to improve access and lower costs. Your legislation does just that, and we strongly support your efforts to remove obsolete policy barriers that prevent Medicare patients from receiving technology enabled, modern health care. We look forward to working with you and your colleagues to pass the TELEhealth for MEDicare (TELE-MED) Act of 2013.
